Arch Reactor: Full Member Agreement

This membership agreement (the "Agreement"), when signed by the signee and a representative of Arch Reactor, constitutes a binding contract between Arch Reactor and the signee, and confers upon the signee all privileges and responsibilities set forth below. Such privileges and responsibilities make the signee a full member of Arch Reactor and commence when the Agreement is signed by both parties hereto.

Full Member Privileges

The following privileges are conferred upon the signee as a full member of Arch Reactor. These privileges shall not be abridged so long as the signee remains in good standing with Arch Reactor. The signee shall enjoy:

- 1. Twenty-four hour access to all areas of the Arch Reactor space.
- 2. Voting rights on all issues, including confirmation of new full members.
- 3. Eligibility to downgrade membership at any time.
- 4. Use of tools and facilities (without supervision) for which the signee has been trained or approved.
- 5. Access to members-only online spaces, such as the "arch-reactor-sanctum" forum.
- 6. A household discount.
- 7. An electronic key which provides twenty-four (24) hour access to the Arch Reactor space.
- 8. Assigned shelf space in Arch Reactor's storage area for a tote box of approximately two (2) cubic feet.
- 9. Use of the Arch Reactor space for functions (parties, meetings, presentations, etc.), provided that:
 - a. The signee is responsible for all clean-up and any damage that may occur as a result of or relating to the signee's function;
 - b. If damage occurs, membership privileges for the signee can be suspended by a simple majority vote of the board until reparations determined by the board have been made;
 - c. The signee cannot prohibit any other full member from attending a function or using the Arch Reactor space, so long that this does not disrupt the scheduled function;
 - d. No member under the age of twenty-one (21) shall be allowed to attend a function where alcohol will be present without a parent or legal guardian;
 - e. The signee must notify the board of his/her intention to hold a function at least fourteen (14) days in advance of the scheduled date; and
 - f. Priority for functions shall be granted on a first-come, first-served basis.

Full Member Responsibilities

The following responsibilities are charged to the signee as a full member of Arch Reactor. The signee must be in compliance with the following in order to remain in good standing with Arch Reactor. The signee must:

- 1. Pay the monthly fee for full members. This is currently set at \$45/month and is subject to change.
- 2. Annually perform a minimum of twenty-four (24) hours of volunteer service for Arch Reactor.
- 3. Contribute regularly to Arch Reactor. Contribution can include creation of works to be used and owned by Arch Reactor for promotion of the organization's services.
- 4. The signee shall at all times follow the instructions of the Sergeant at Arms with respect to properly using Arch Reactor equipment.

5. Forfeit to the Sergeant at Arms all access to the space and all property owned by Arch Reactor when the signee's membership ends.

Term

The Agreement shall remain in effect so long as the signee maintains good standing with Arch Reactor. The signee maintains the right to terminate his/her membership and, thus, this Agreement at any time.

Assignment

No assignment of this Agreement, or the signee's privileges and responsibilities hereunder, by the signee shall be valid without the prior written consent of Arch Reactor.

Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Missouri, without regard to its conflicts of law principles.

Waiver

Any failure or delay by either party hereto in exercising any right or remedy shall not be deemed a waiver of any further, prior, or future right or remedy hereunder.

Severability

If any provision of this Agreement is determined to be invalid and/or unenforceable, the other provisions of the Agreement shall remain unaffected, and shall survive and remain in full force and effect.

Effectiveness and Interpretation of Agreement

This Agreement sets forth the entire understanding between the parties hereto, and supersedes any oral or prior written agreements. Any modifications or changes to this Agreement must be in written form and signed by both parties hereto.

FURTHER EACH PARTY HERETO AGREES THAT THE ELECTRONIC SIGNATURES OF THE PARTIES HERETO ARE INTENDED TO AUTHENTICATE THIS WRITING AND TO HAVE THE SAME FORCE AND LEGAL EFFECT AS MANUAL SIGNATURES.
